Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations), we have to inform you that Davendra Feeds India Private Limited (CIN No. U15331HR2010PTC041044) registered with ROC-Delhi has lodged F.I.R. bearing no. 231 of 24.06.2022 with police station Safidon District Jind Haryana (intimation of which has been received by us on June 25, 2022) against Chembond Chemicals Limited, Mr Sameer Shah (Chairman & Managing Director) and 3 other current & ex-employees with respect to alleged inferior quality of material supply, cheating and breach of trust.

The Company strongly denies and disputes the claims made against it and is taking the necessary legal steps in the matter. The details as required under Regulation 30 of the Listing Regulations are as under:

a.	Brief details of litigation viz. name(s) of the opposing party, court / tribunal / agency where litigation is filed, brief details of dispute / litigation	FIR No 231/ 2022 in Safidon Police Station District Jind Haryana lodged by Davendra Feeds India Private Limited (CIN No. U15331HR2010PTC041044), regarding alleged defective supply of vitamin premix in the year 2018-2019. However, no material has ever been supplied by Chembond Chemicals Limited to Davendra Feeds India Private Limited.
b.	Expected financial implications, if any, due to compensation, penalty etc.	NIL, as the matter does not pertain to civil liability.
c.	While no liability is expected, it	NIL.

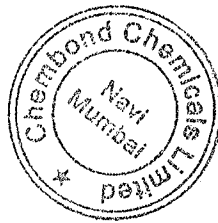
